We are pleased to respond to your request for Professional Services on the above referenced project. By way of this Contract, we are enclosing our understanding of the scope of work required for the project and shall perform the Professional Services upon the terms and conditions set forth in this letter.

I. The following represents our understanding of the project description:

A2H will be responsible for professional design and consulting services necessary for the Street Overlay Paving Program proposed in Covington, TN.

RE: Animal Control

Points to consider for discussion.

To my knowledge the City has only provided a minimum animal control service to our residences.

Animal control has been provided through the Public Works Department, currently it is shared between the PW and Code departments. In the past the Building Official and his duties was a division of Public Works even though the Building Official was included with the other Directors in the Municipal Code. During Mayor Hanson's administration the Building Official and his duties along with new duties have been separated from the PW department. The Public Works Director and the Code Compliance Director are still working on separating whom should be responsible for some duties. During this amendment to the Covington Municipal Code the Director of Public Works will be included in being able to summons violators to Municipal Court the same as the Fire Chief and Building Official along with their designees have authority to do. I feel this will help with the separation of responsibilities. One of the key points Chairman Wallace made during a discussion is that it is difficult for our employees to have more than one person to be accountable to.

Recently there was an interaction with the Tipton County Animal Shelter that made me feel I needed to have discussion regarding the future of the City providing animal control services.

The timing seems appropriate since the City is in budget discussion. During conservation with Mayor Hanson, it was determined for us to consider if by State law the City is required to provide such service and to see how the other jurisdictions in Tipton County handle these services. I emailed Ronnie Neill to confirm the State requirements. Mr. Neill replied he is unaware of any law that requires the City to address animal control. Mr. Neill did note that T.C.A. 44-8-408 makes it unlawful for dogs to run at large. He noted that in most of the counties that he works in, the county government is usually responsible for animals running at large.

The Town of Atoka, Town of Brighton, and City of Munford to not have shelters or pounds nor do they contribute any funding through their budget to assist with the operations of the TCAS.

Even though the City has a page on our website for animal control it seems to me as if most residences are unaware of our pound and contact the TCAS for assistance. I make this statement due to the number of calls and text we receive from employees at the TCAS regarding concerns in the City.

I feel our residents would be better served by a department that is designated to specifically providing animal control services even if that department is a County department of which our residences already help fund through property taxes and sales tax dollars. One of Chairman Wallace's concerns is if there is enough savings to the City to stop providing the service through the City. I do not feel providing these services should be viewed by the savings which is hard to measure since animal control is a small percent of the hours works by employees in two of the Cities departments. I feel that the City would better serve our residents in their other duties and that there would be a better service provided to the residents and animals if the TCAS handled the animal control services in the City.

When residents see or experience the following, they typically call 911 or dispatch for assistance:

Dogs running at large,

Dog bites,

Dogs left in an automobile, house,

Dogs that are being abused or neglected.

All the above scenarios can be better addressed in the General Session Court. In the Municipal Court the Judge may only charge court cost and a maximum fine of \$50.00 per violation, of which the City has no means to collect. Those that appear in the Municipal Court are quick to share that information with others.
