GENERAL SUMMARY:

- Performs a variety of semi-skilled and skilled task in the maintenance work, and operates a variety of equipment in the construction, operation, repair, maintenance and replacement of City gas water and sewer facilities and systems.

SUMMARY OF JOB RESPONSIBILITIES:

- Plans and organizes and implements construction maintenance and operation of activities designed to provide quality gas, water and sewer service for the city.
- Inspects and/or repairs regulator stations, pumping stations, meters and sewer systems
- Assist in projecting needs for equipment purchases, materials and supplies
- Maintains a variety of records
- Responds to complaints
- Drives trucks of various sizes and weights
- Performs labor involved in construction and maintenance as part of a crew including pavement cutting, ditch digging, manhole and line cleaning, main and pipe repair laying and backfilling.
- High School diploma or GED.
- Valid TN Drivers License **with CDL endorsement or able to obtain upon employment**
- Two years of experience relating to construction, maintenance or repair of gas water and sewer systems including operation of related maintenance equipment
- Ability to perform heavy manual tasks for extended periods of time; ability to work safely; ability to communicate effectively verbally and in writing

WORKING CONDITIONS AND PHYSICAL EFFORT:

Standing for extended periods of time, must be able to frequently lift and or move at least 25lbs and occasionally lift 100 lbs. Must be able to perform strenuous physical labor safely. Must be able to hear a wide variety of sounds. Specific vision abilities required for this position include a close vision, distance vision, peripheral vision, depth perception and ability to adjust focus.
