Detectives utilized a confidential informant, under the age of 21, to enter the establishment to purchase alcohol. The confidential informant , monitored by undercover Detective Dillingham, successfully purchased a 23.5 oz. can of Mike's Harder Cranberry Lemonade after the cashier checked the confidential informant's identification. The cashier that made the sale was identified as Bri'Anna Wakefield and was cited into Tipton County General Sessions Court Sale of Beer to Minors. The manger on duty, Maurice Vasser, then contacted the one of the owners and beer permit holder, Judson Naifeh, and notified him that the violation had a occurred. Later a violation notification letter was sent by certified mail to the business address. Bri'Anna Wakefield is no longer employed by Naifeh's LLC dba Naifeh's Cash Saver.

HISTORY:

Naifeh's, LLC dba Naifeh's Cash Saver received a Permit to sell Beer from the Covington Beer Board for Off Premise Consumption on the 23rd day of March 2021. This is their first violation under this this permit and location.

Naifeh's LLC dba Naifeh's Cash Saver is a Responsible Vendor as recognized by the Tennessee Alcoholic Beverage Commission. Their employees that sell intoxicating beverages are all certified and Naifeh's LLC dba Naifeh's Cash Saver has provided that proof to the staff.
