Meeting was called to order by Chairman Joe Auger.

Motion was made by Alice Fisher and seconded by Sue Rose that the minutes of the preceding meeting be approved. Motion passed.

Site Plan was submitted to construct a new Captain D's restaurant on Highway 51 North. The property can be described as Parcel 20.00 on Tipton County Tax Map 025N Group C. The plans will be submitted in 2 parts, first building and solar panels will process at later date. Greg Bartlett confirmed that there will be no connection to Bethel Street. Louise McBride asked about an easement connecting north and south properties. Lessie Fisher explained TDOT has new driveway access requirements.

Motion was made by Alice Fisher and seconded by Sue Rose to approve contingent upon storm drainage issues being addressed. Motion passed.
