Treasurer-Recorder Elam reported sales tax received for the December collections were \$467,889, which is a decrease of \$120,246 or -20.4%. Year-to-date collections for fiscal year 2024 are \$2,522,731 which is a decrease of \$5,993 or - 0.2%.

The parts have been ordered for the Water Well #7 which are due by the end of April. Director Haynes announced that bulk leaf removal has been stopped, and all leaf removal will now need to be bagged. Director Haynes also reported he plans to use the USDA/WELP Grant Funds to upgrade Wastewater Screw Pumps to Flygt Pumps, contingent on approval from A2H getting the grant amended for the purchase of the Flygt Pumps.

Public Works Director Haynes reported the request for the Hwy 51 sewer line to extend to Hogan Road and turn to continue to Grant Lane to keep in line with the City's growth region.

Building Official Lessie Fisher reported the Blight Grant. Director Fisher plans to have the final revisions/updates to Mattie by March 38th. Director Fisher stated on March 25th she performed a walk through with Jeff Eakes to confirm what needs to be included in that write-up. Director Fisher reported on

Property Maintenance concerns stating notices of violations were mailed for 181 Ervin Lane.

Alderman Wallace stated he would like Warning Tickets issued to be issued for vehicles that do not have current registration and/or multiple vehicles on streets. Director Fisher reported that the new Pizza-Hut is having a Health Department Inspection tomorrow. Director Fisher reported bids for HVAC and Plumbing will run in the Leader on 4-23-25. The Bid Opening will be on 4-21-25 at City Hall.

A RESOLUTION OF THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF COVINGTON, TENNESSEE, EXPRESSING SUPPORT FOR FORD MOTOR COMPANY'S BLUEOVAL CITY PROJECT

A RESOLUTION of the Board of Mayor and Aldermen of the City of Covington, Tennessee, to express support for Ford Motor Company's BlueOval City project and recognize its significant economic impact on Tennessee.

WHEREAS, Tennessee has established itself as a global leader in automotive production, continuing the state's legacy of manufacturing excellence; and

WHEREAS, BlueOval City is projected to create approximately 6,000 new high-quality jobs for hardworking Tennesseans, offering competitive wages and benefits that support Tennessee families; and

WHEREAS, Ford Motor Company announced a \$5.6 billion investment to build BlueOval City, an advanced vehicle and battery manufacturing campus in Stanton, Tennessee; and

WHEREAS, BlueOval City represents one of the largest manufacturing investments in Tennessee history, further strengthening the state's tradition of American manufacturing; and

WHEREAS, BlueOval City will produce significant tax revenue for local communities and support new and existing small businesses, contributing up to \$3.5 billion annually to Tennessee's gross state product; and

WHEREAS, BlueOval City will revitalize rural communities in West Tennessee, providing economic opportunities that support future generations; and

WHEREAS, the collaboration between BlueOval City, Ford, BlueOval SK, the State of Tennessee, and the Tennessee Valley Authority has resulted in over \$500 million in public infrastructure investment for the region; and

WHEREAS, Ford Motor Company has pledged \$30 million through Ford Philanthropy and the Good Neighbor Plan to invest in workforce development, farmers and small businesses, literacy programs, youth initiatives, and community spaces in West Tennessee; and

WHEREAS, BlueOval City will help maintain America's competitiveness in automotive manufacturing, preserving technological leadership and industrial capabilities; and

WHEREAS, the Tennessee General Assembly recognizes the importance of supporting American companies that invest in American workers and communities;

NOW, THEREFORE, BE IT RESOLVED By the Board of Mayor and Aldermen of the City of Covington, Tennessee, that we hereby express our strong support for Ford Motor Company's BlueOval City project and acknowledge its substantial economic benefits and job creation potential for the citizens of Tennessee.

FURTHERMORE, BE IT RESOLVED that we support policies at the federal and state levels that sustain Ford's investment in BlueOval City, fostering growth and opportunity for families in West Tennessee and beyond.
